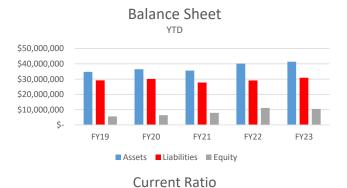
- > Due to advance per pupil payment, the total cash has been increased to 10.4m compared to 8.6m last month.
